## Rates & Fees

### Most Common Rates & Fees Assessed:

**Minimum Monthly Base Fee Without Water Usage** (based on standard residential 3/4 x 5/8 meter) **\$56.60.**

**Late Fee** (if payment is received on or after the 11<sup>th</sup> of the month) **15.00**

**Service Trip Fee** **45.00**

A service trip fee is charged to members if water supply personnel must make a trip to a meter to perform services outside of the scope of normal job duties such as, cutting a meter off to prevent pipes from freezing; to repair damage to a meter caused by the member or the member's tenants/guests/family; or, *to cutoff a meter for non-payment.*)

**Reconnect Fee** **45.00**

If a meter is cutoff for non-payment of a bill, this fee must be paid *and* members are required to update their service agreement applications as well as meet any other requirements of the Corporation before service can be re-established.

### **Regulatory Assessment**

A charge assessed by the Texas Commission on Environmental Quality to regulate water supply entities. This charge is ½% of the total monthly bill, which includes minimum fee and water usage.

**Customer History Report** **First 3 pages 0.50 per page thereafter** **2.00**
